## What really happened on October the 7<sup>th</sup>?

The events that unfolded on October 7th cast a dark shadow over the international community, raising profound concerns about the ethics of warfare and the protection of civilian lives.

The Israeli aggression, spanning a small geographical area but leaving a devastating impact, has become emblematic of the challenges faced by those seeking truth and justice in the face of conflicting narratives.

The scale of the onslaught, with the Gaza Strip enduring a bombardment equivalent so far to three nuclear bombs, has not only resulted in a staggering number of casualties but has also exposed the vulnerabilities of innocent civilians, predominantly comprising women and children.

The international response has been polarized, with approximately 20 countries providing direct support to the Israeli occupation in the form of military or intelligence collaboration, while others contribute political and media cover that amplifies the Israeli narrative.

Despite mounting evidence revealing a series of fabrications, including horrific accounts of decapitated children and mass rape, the Israeli narrative continues to pivot on the alleged deliberate targeting of civilians on October 7th.

The Kibbutz of Be'eri and the Nova music festival in Re'im have been highlighted as focal points of what happened on October 7th.

Media coverage, marked by sensationalized phrases such as "unprecedented massacre" and comparisons to historical atrocities like the Holocaust, has further complicated efforts to discern the truth.

In the aftermath, attempts to conduct impartial investigations or request evidence have been met with vehement resistance.

Accusations of anti-Semitism, Holocaust denial, and accusations of supporting terrorism have been weaponized to stifle any dissent or pursuit of objective truth.

This raises serious questions about the freedom of inquiry and the ability to hold those responsible for atrocities accountable.

# Before delving into the core of this report, it is crucial to clarify the following points:

- The history did not commence on October 7, 2023; rather, it unfolds as a continuous saga spanning over 80 years, predating the establishment of "Israel." This was emphasized by António Guterres, the Secretary-General of the United Nations, sparking a contentious reaction from Israel.
- The events of October 7, despite the substantial number of casualties, do not represent the worst the region has endured. Atrocities far more heinous have scarred the area, including the Sabra and Shatila massacre in 1982 and the Srebrenica massacre in Bosnia in 1995.
- The intention in the above points is not to diminish the gravity of the events or to deny them but to elucidate how the occurrences were magnified and exploited in the most egregious manner to justify subsequent war crimes and ongoing genocide against the inhabitants of the Gaza Strip.
- The forthcoming discussion does not serve as justification, glorification, or support for any movement, organization, or group. It strictly adheres to the laws in this country and most Western nations. Instead, it aims to relay what transpired on that day.
- The information presented relies on Israeli sources specifically, citing reports, newspapers, interviews, and statements that paint a narrative completely contrary to the official Israeli account, even undermining it at its roots.
- These Israeli sources cast doubt on who was responsible for the civilian casualties on that day. Did

Hamas solely bear the responsibility for their deaths? On the contrary, they assert that the occupying forces intentionally killed their own "citizens" on direct orders from officials.

 The presentation of these reports and their findings completely dismantles the justifications put forth by the occupation for its ongoing criminal aggression against the Gaza Strip. It challenges the political and media narrative that the Western media often perpetuates, supporting war crimes and genocide against the people of Gaza.

#### **First: The Numbers**

- 1) From the very first day, October 7<sup>th</sup>, the Israeli narrative began circulating the figure of 1,400 Israeli casualties, even before Israeli forces entered the penetrated areas. Subsequently, Western media embraced this narrative and disseminated it without thorough verification, turning it into an endorsed statistic.
- 2) The Zaka Foundation, widely believed as the primary source for misinformation, published a report on October 23, 2023, claiming 1,400 casualties, including 863 civilians. This further propagated the inflated casualty figures, contributing to the narrative that painted a dire picture of the situation.

The lack of scrutiny in the dissemination of these numbers raises questions about the accuracy and intent behind the information shared by both Israeli sources and the Western media. This episode underscores the importance of fact-checking and critical analysis in the reporting of such sensitive events.

**3)** In the unfolding events of 2023, on November 10<sup>th</sup>, the Israeli foreign ministry released what they termed an "updated estimate," vaguely stating that the number stood at approximately 1,200 individuals.

**4)** On Thursday, November 16<sup>th</sup>, 2023, in a candid moment on the show, Mark Regev, the official spokesperson for the Israeli government, acknowledged the following during an interview with Mehdi Hasan on MSNBC:

"We originally said, in the atrocious Hamas attack upon our people on October 7th, we had the number at 1,400 casualties and now we've revised that down to 1,200 because we understood that we'd overestimated, we made a mistake. There were actually bodies that were so badly burnt we thought they were ours, in the end apparently they were Hamas terrorists"

This acknowledgment raises a crucial question: If the 200 individuals mentioned were fighters in their burning vehicles with "hostages," how many Israelis were killed in the same airstrike targeting these Gaza militants?

The incident transformed their vehicles and bodies into charred remains.

It simply makes no sense that 200 bodies burned beyond recognition that Israel thought were Israeli civilians could turn out to be Hamas fighters unless Israel killed people indiscriminately.

Obviously, Hamas fighters did not set themselves on fire and burn themselves beyond recognition.

Israel must know the circumstances in which these people died.

**5)** On December 15, the tally was once again revised, bringing the figure to 1,139 individuals. According to the Israeli Social Security institution, Bituah Leumi,

- this includes 695 civilians, marking a decrease from the previously stated 863 civilians in October.

The continual adjustment of the numbers raises significant questions about the precision and reliability of the initial casualty estimates.

This fluctuation not only underscores the importance of transparent reporting but also emphasizes the need for thorough and accurate data collection methods in documenting such sensitive matters.

For the purpose of discussion and to establish a baseline, let us consider that, up to this moment, the number of Israeli civilian casualties stands at 695.

This is despite the numerous falsehoods accompanying the statistics, especially regarding the details of the fatalities, including children, as highlighted in a report by Nir Hasson and Lisa Roseofsky in the Hebrew newspaper Haaretz dated December 3, 2023.

After more than three months since the events of October 7<sup>th</sup> 2023, the figures continue to fluctuate and evolve.

More details are emerging about the circumstances surrounding these casualties and the party responsible for the loss of lives.

It remains a possibility that the numbers and statistics may undergo changes over time.

The Israeli narrative has consistently demonstrated a penchant for blatant falsehoods in its coverage of various incidents. Therefore, a critical approach is essential in assessing the veracity of the reported figures and the evolving narrative.

#### **Second: Testimonials**

It is now widely acknowledged that on October 7<sup>th</sup>, Israel's military received directives to shell Israeli homes and even their own bases as they faced overwhelming attacks from Hamas militants.

The question arises: <u>how many Israeli citizens</u>, <u>purportedly</u> "burned alive," were actually casualties of friendly fire?

Here, we review some testimonies from Israeli witnesses known as "survivors of the massacre" on October 7<sup>th</sup>. These testimonies, originating from various locations, align perfectly, leaving no room for doubt that Israeli forces indiscriminately fired upon their own citizens, resulting in an unknown number of casualties.

Despite the diverse sources, these testimonies collectively paint a clear and specific picture. They suggest that the Israeli military, in a state of chaos, targeted its own citizens without discrimination, leading to an undisclosed number of fatalities.

The consistency in these accounts raises serious questions about the conduct of Israeli forces during the events of October 7<sup>th</sup>, challenging the official narrative and demanding a thorough investigation into the tragic consequences of that day.

7) On 7 October, Israeli military spokesperson Rear Admiral Daniel Hagari publicly acknowledged the Israeli army was dealing with "hostage situations" and that they were using both air strikes and ground forces to deal with them.

Hagari said the military was "fighting in 22 locations," adding there was "no community in southern Israel where we do not have forces, in all the towns." **8)** An air force colonel has said that Israeli airstrikes may have intentionally killed Israeli captives rather than let them be taken to Gaza.

Speaking in Hebrew about the airstrikes, **Colonel Nof Erez** told a Haaretz podcast in November, that "the Hannibal Directive was apparently applied" and that 7 October "was a mass Hannibal."

9) Tuval Escapa, a member of the security team for Kibbutz Be'eri, set up a hotline to coordinate between kibbutz residents and the Israeli army. He told the Israeli newspaper Haaretz that as desperation began to set in, "the commanders in the field made difficult decisions – including shelling houses on their occupants in order to eliminate the terrorists along with the hostages."

**10)** On 15 October 2023 An Israeli woman named **Yasmin Porat** confirmed in an interview with Israel Radio that the military "undoubtedly" killed numerous Israeli non-combatant during gun battles with Hamas militants on October 7. "They eliminated everyone, including the hostages," she stated, referring to Israeli special forces.

Porat released a video about what she witnessed

Porat described "very, very heavy crossfire" and Israeli tank shelling, which led to many casualties among Israelis.

While being held by the Hamas gunmen, Porat <u>recalled</u>, "They did not abuse us. We were treated very humanely... No one treated us violently."

She added, "The objective was to kidnap us to Gaza, not to murder us"

11) In an interview with Israel's Mako news outlet, one Apache pilot reflected on the tortuous dilemma of whether to shoot at people and cars returning to Gaza. He knew that many of those vehicles may have contained Israeli captives, but he chose to open fire anyway.

"I choose targets like that," the pilot reflected, "where I tell myself that the chance that I am shooting here on hostages as well is low." However, he admitted that his judgment "was not 100%."

"I understand that we have to shoot here and quickly," the commander of the Apache unit, Lt. Col. E., told Mako in a separate report. "Shooting at people in our territory – this is something I never thought I would do."


**Lt. Col. A**., a reserve pilot in the same unit, described a fog of confusion: "I find myself in a dilemma as to what to shoot at, because there are so many of them."

12) A resident of Ashkelon named **Danielle Rachiel** described nearly being killed after escaping from the Nova music festival when it was attacked by militants from Gaza. "As we reached the roundabout [at a

kibbutz], we saw Israeli security forces!" Rachiel recalled. "We held our heads down [because] we automatically knew they'd be suspicious of us, in a small beat-up car... from the same direction the terrorists were coming from. Our forces began shooting at us!"

"When our forces fired at us, our windows shattered," she continued. It was only when they shouted in Hebrew, "We're Israelis!" that the shooting stopped, and they were taken to safety.

**Ayos** told of how Ayos was driving to report for duty on Sunday, October 8<sup>th</sup>, when Israeli forces misidentified him as a terrorist, and opened fire. His mother, a lawyer who intends to file a lawsuit over the incident, said that when she retrieved his car, "it looks like a pasta strainer." The autopsy revealed that he'd been shot about 100 times.

16) A separate report published in Haaretz noted that the Israeli military was "compelled to request an aerial strike" against its own facility inside the Erez Crossing to Gaza "in order to repulse the terrorists" who had seized control. That base was filled with Israeli Civil Administration officers and soldiers at the time.

17) An Israeli who was released in the recent prisoner swap between the occupation and Hamas said that her mother was killed as a result of the occupation army shooting at the car that was

transporting them to Gaza, as they were being taken as prisoners of war on 7 October.

In an interview broadcast on Israel's **Channel 12** on 18 December 2023, she said: "Al-Qassam Brigades fighters put the hostages in a truck on October 7<sup>th</sup>, and Israeli forces opened fire on the vehicle."

She added, "My mother, whom I loved very much, died. I was injured in my back, and my brother was injured in his leg."

The channel claimed that the Israeli army "opened fire to stop a tractor that was heading to the Gaza Strip."

**18)** 22 December 2023 - **Commander of the 99th Army Division**, in an interview with the New York Times:

During the Hamas attack in October, "I ordered the bombing of homes in the Be'eri settlement, even if this resulted in the deaths of settlers."

"The negotiations are over," General Hiram recalled telling the tank commander. "Break in, even at the cost of civilian casualties."

The tank fired two light shells at the house.

Shrapnel from the second shell hit Mr. Dagan in the neck, severing an artery and killing him, his wife said.

During the melee, the kidnappers were also killed.

Only two of the 14 hostages — Ms. Dagan and Ms. Porat — survived.

#### **Fourth: Photos**

The extensive devastation that befell the Gaza periphery on October 7<sup>th</sup>, 2023, offering a stark contrast to the idea of lightweight individual weapons wielded by militants from Gaza.

Israel has also never explained how Palestinians fighters could have achieved this or caused the enormous damage to Israeli houses with only the light weapons they were generally seen carrying.

These compelling images decisively affirm that the affected areas and structures fell victim to a barrage of artillery, tank shells, and aerial bombardment, dispelling any notion that attributes the destruction to individual weapons. The visual evidence presented resonates with similar scenes documented across the globe, encompassing regions such as Gaza and southern Lebanon.

These depictions underscore the repercussions of both ground and aerial assaults, offering a glimpse into the profound nature of the resulting devastation.

#### Fifth: Refusal of Independent Investigation/Censorship

#### Conclusion

According to the Israeli narrative, the majority of civilian casualties occurred at the Nova music event and the Kibbutz Be'eri.

Eyewitness testimonies from these areas were crucial in revealing the IDF's indiscriminate use of ground and aerial bombardment, suggesting that a significant proportion of civilian deaths resulted from Israeli military actions.

Moreover, it is likely that the actual death toll (of those killed by the IDF) is higher, considering witness accounts reporting Apache helicopters reloading three times and firing indiscriminately at fleeing crowds. The incident is described as an immense and complex free-fire zone.

These revelations challenge the official Israeli narrative, highlighting the following points:

- The IDF acted as brutal and trigger-happy mass murderers, causing civilian casualties among both Palestinians and Israelis.
- Some Israeli captives were still alive two days after the events of October 7th.
- Hostages were not only caught in crossfire but deliberately targeted by the IDF using tank shells and heavy weaponry in close proximity.
- The IDF, not the Palestinians, contributed to Israeli civilian deaths used to justify military actions against Gaza.
- Autopsy results, revealing the type of bullets used, could confirm the extent of IDF responsibility.
- Army spokesperson Daniel Hagari acknowledged a "substantial" number of hostages taken by Hamas being military officers.

Unverified, exaggerated, and false accounts of atrocities have been utilized to justify Israel's ongoing aggression, war crimes and genocide in Gaza.

Despite success with Western governments and media, Israel's propaganda campaign has faced scepticism from the public, overshadowed by the civilian casualties in Gaza.

Reports suggest that the attack on October 7<sup>th</sup> aimed to capture Israelis army and police for potential exchange with Palestinian prisoners. The unexpected collapse of the Israeli army in the initial 30 minutes led to chaos and civilian casualties.

Questions persist about the attack's true purpose, whether to maximize civilian casualties, as per the Israeli narrative, or if gunmen from Gaza were responsible for all civilian deaths.

The Israeli claims justifying actions in Gaza cannot be accepted, as the narrative of victimhood crumbles against solid evidence.

Accountability is crucial, and those responsible must be pursued and punished, regardless of their affiliation.

A call for an independent international committee or a fact-finding mission is essential, echoing the demand made by the families of Israeli civilians killed on October 7<sup>th</sup>, is the only way forward.

This approach is deemed necessary to uncover the truth behind the events of that day.
